Dear Commissioners,

The 2015 seismic testing activity in Gem County resulted in the illegal discharge of oil and soil contamination to private property by Alta Mesa's subcontractor Dawson Geophysical.

It is my understanding that Alta Mesa paid Robert Disidori to keep quiet about this incident.

The purpose of this letter is to reiterate the need for a "Statement" clause within the proposed Gem County oil & gas ordinance. Additionally, I ask you to contact IDL for the purpose of adding this clause into the IDAPA rules currently being revised.

Please find noted below an example:

A statement as to whether the Applicant/Operator has operated a site where a release occurred, where there was a violation of any provision of Local, State or Federal statutes, or where there was a finding that a nuisance existed; describe each release, violation, or nuisance, and specify the date, place, jurisdiction and any emergency and/or remediation action taken.
