Hi all,

Apologies for the delay. IDL staff and I have reviewed Mr. Hansen's 'corrected drawing with new dimensions.' While this adjustment to the application purportedly resolves the Objectors' concerns with respect to the location of the Olinger dock, it does not cure IDL's concern regarding the Vedadi boat garage's conflicting width measurements. IDL Prehearing Statement <<https://www.idl.idaho.gov/wp-content/uploads/sites/2/2026/03/027-PLD-2026.03.20-IDL-Prehearing-Statement-OHVD-Laneco.pdf>>, 13.

In addition, if the applicant wishes to proceed with relocating the Olinger dock as proposed here, IDL will need some additional information and updated drawings showing the new proposed placement of the Olinger dock on the river. The single drawing provided so far is not enough for IDL to fully evaluate the revised proposal. IDL is happy to work with Mr. Hansen to get the necessary information if the applicant does wish to pursue this amendment.

Finally, it has come to my attention that the Kootenai County Sheriff's Office marine deputies and members of the public may be interested in attending the hearing as there are ongoing concerns in the community about navigating the Spokane River and its pinch points.

With the need for additional information regarding the adjustment of the Olinger dock, the lack of resolution of the question regarding the Vedadi boat

garage's width measurement, and the public interest in the application combined, IDL believes the public hearing should proceed as scheduled at this time.
