

## Driving directions to Riverside Hotel from the Boise Airport:

From the Boise Airport

- drive North approximately 2.2 miles on S. Vista Avenue which becomes Capitol Blvd;
- turn left onto W. Front Street and continue onto I-184W for approximately 1 mile;
- take the US-20 W/US-26 W exit toward Garden City/Fair Grounds to Chinden Blvd;
- the hotel will be on the right at 2900 East Chinden Blvd.
