ORDER

The parties convened for a Scheduling Conference at the call of the Hearing Officer on January 10, 2019. Counsel for all parties were in attendance. During the course of the conference, it was apparent that there was basic disagreement regarding the issues to be addressed in this matter, whether discovery was appropriate or necessary, and the scheduling necessary for the proceeding.

The Hearing Officer advised the parties to confer during the course of the two following weeks to develop an agreed schedule to include a course of proceedings, resolution of discovery issues, and agreement on other matters to narrow the issues in dispute. The parties were advised that failing such an agreement, the parties were to submit proposed scheduling orders addressing such matters by February 28, 2019. The Intervenors would have an additional five days in which to submit any concerns regarding Respondent's proposed order. The Hearing Officer, having received no notice of an agreement on these matters within the prescribed two-week period, hereby orders as follows:

IT IS HEREBY ORDERED that the Petitioner and Respondent each submit a proposed scheduling order detailing the following:

- a) Any factual issues to be determined at a hearing.
- b) Any legal issues to be decided at or before a hearing, including the basis for seeking a declaratory ruling in this matter.
- c) The necessity and basis for discovery, the type of discovery requested, and particular type of information sought to be obtained.
- d) The necessity and timing for resolution of prehearing matters.
- e) A proposed time frame for hearing this matter, including an estimate of the time necessary for hearing.


