Idaho auctions seven commercial properties for \$17.3 million

(BOISE) – The Idaho Department of Lands (IDL) sold seven commercial properties today for \$17,265,000 at an auction in Meridian. All bids totaled \$4,475,000 above the appraised price of the properties.

Six commercial properties in Boise and one in Idaho Falls sold. Two other properties in Idaho Falls were offered for auction but did not sell.

Highlights from today's auction include:

- Three downtown Boise properties the Sherm Perry building in which 10 Barrel is located (826 W. Bannock Street), the Garro building (816 W. Bannock Street), and the Garro building parking lot (822 W. Bannock Street) sold together as one package for \$6,575,000, or \$2,030,000 more than the appraised price of the properties.
- Affordable Storage located at 448-450 S. Maple Grove Road in Boise sold for \$4.7 million, or \$1,690,000 more than its appraised price.
- The former bank building located at the corner of 8th and State Streets in downtown Boise across from the Capitol sold for \$1,475,000, or \$645,000 more than its appraised price.
- The office building located at 602 N. Fifth Street in downtown Boise referenced as "Central Washington Place"
 sold for \$4,185,000 with no competitive bidding.
- A parking lot located at 961 E. Lincoln Road in Idaho Falls sold for \$330,000, or \$110,000 more than its appraised price.

A full list of the auctioned properties and winning bids is attached.

Approximately 200 people attended the auction and there were 48 registered bidders.

The Idaho Constitution requires a public auction for the disposal of state endowment trust lands, and IDL can accept no less than the appraised value of the properties.

BACKGROUND

Endowment assets, including commercial property, are assigned by law to specific beneficiaries. The commercial property is owned by certain endowment beneficiaries including the Public Schools Fund, Normal School Fund, State Hospital South Fund, and the University of Idaho Fund.

Endowment lands are managed under a constitutional mandate to maximize long-term financial returns to the trust beneficiaries, the largest of which is Idaho's public school system. The State Board of Land Commissioners (Land Board)

– comprised of Idaho's governor, secretary of state, attorney general, state controller and superintendent of public instruction – provides direction to IDL on the daily management of the Endowment lands.

The Land Board voted in 2016 to auction most IDL commercial properties. The decision was based on the recommendation by the Land Board's general investment and real estate consultants that there was no compelling investment reason for direct ownership of commercial properties. A business plan prepared for the commercial properties pointed to current market conditions as well as the challenges and limitations IDL faces in efficiently owning and operating commercial real estate as reasons for divesting of most of the commercial properties. Proceeds from the sale of the properties may be used to purchase other lands in Idaho – such as timberland or farmland – to improve long-term returns for the endowed beneficiaries or may be directed to the permanent fund.
