The Applicant, Gregory M. Wilson objects and protests to proceeding in the above captioned matter pursuant to Idaho Code 58-1306(c). On October 25, 2022, the Hearing Coordinator scheduled a public hearing on Applicant's Encroachment Permit Application No. L-97-S-1081C (the "Application"). The public hearing is scheduled for December 19, 2022, at 9:00 a.m. Pacific Standard Time.


Applicant objects, protests, and challenges the Board's legal authority to initiate a contested case and hold a public hearing on this Application. The reasons include, but are not limited to, the following:

1. The Board failed to comply with Idaho Code 58-1306(b). It never published Notice of the Application in a newspaper having general circulation in Bonner County, Idaho.
2. The Board failed to comply with Idaho Code 58-1306(c). There was no timely objection to the Application. Neither IDL nor any Objector timely requested a hearing on the Application.
3. The Board did not hold a hearing within the statutes required ninety (90) day period following IDL's receipt of the Application on June 15, 2021.

4. The Board's failure to hold the requisite hearing within 90 days of June 15, 2021, divested the Board of its legal authority to order a hearing on this Application sixteen (16) months later.

5. On October 17, 2022, at the initial Scheduling Conference, Applicant revoked and retracted all waivers, offered no waivers, offered no consents, and reserved all rights in this matter. Applicant affirms those statements.
