

The 2015 Idaho Legislature passed Senate Concurrent Resolution 126 requesting the Idaho Department of Lands to develop Good Neighbor Authority agreements with federal agencies to carry out forest, rangeland and watershed restoration activities on federal lands within Idaho.

GNA authorizes IDL to utilize state processes and personnel to assist the USFS and Bureau of Land Management with these types of authorized activities.

Approximately 12.6 million acres of the 20.4 million acres of National Forest lands in Idaho are suitable for active management.

In accordance with the 2014 Farm Bill and amended Healthy Forests Restoration Act, 6.1 million of these acres have been designated for treatment due to the threat of insect and disease outbreaks or wildfire.

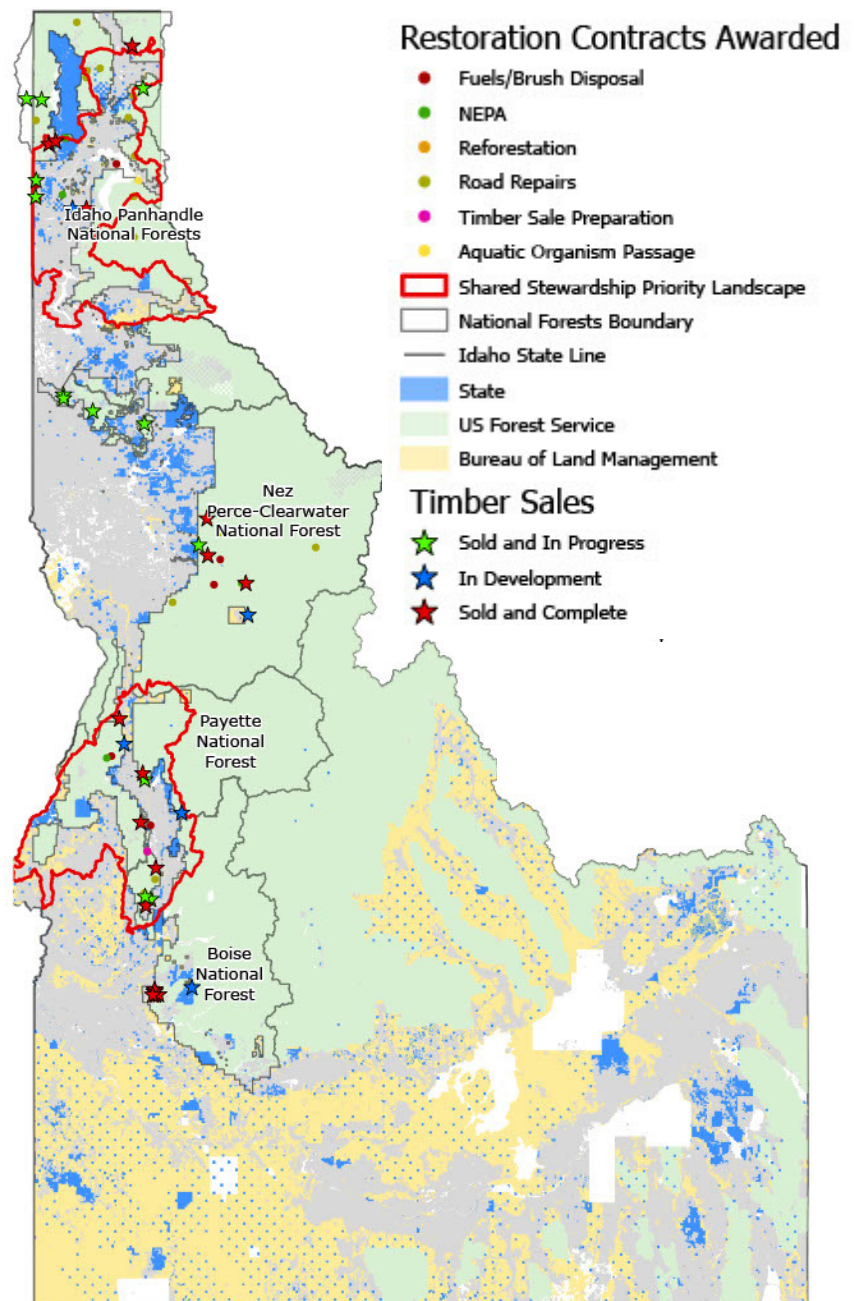
The 2018 Agreement for Shared Stewardship between the state of Idaho and Regions 1 and 4 of the USFS formalized interagency efforts to prioritize and expedite landscape level treatments focused on fuels reduction and improved forest, rangeland, and watershed conditions.

Using advanced scientific tools and spatial analyses, IDL and the U.S. Forest Service identified two Shared Stewardship priority landscapes to focus resources to protect communities and mitigate threats to Idaho's forests. Through GNA, IDL is also working throughout Idaho using this shared stewardship approach to plan and implement projects across jurisdictional boundaries.

To date, IDL has awarded 36 commercial timber sales and 151 service contracts for restoration work on federal lands. Revenues generated from GNA timber sales aimed at reducing the threat of wildfire, insect, and disease fund IDL's staff and other restoration activities such as prescribed burning, road repairs, and environmental planning for future work. These commercial projects also contribute additional forest outputs from federal lands sustaining manufacturing, logging, trucking, and road construction jobs in many of Idaho's economies.

The information reported here summarizes GNA project accomplishments by IDL and cooperating agencies from 2016 to 2022 in support of Shared Stewardship projects and more.

2022 Accomplishments

Timber Sales

- Awarded 10 timber sales, which will generate approximately 18.5 million board feet of timber, treat 1,202 acres, and generate \$3.4 million
- Awarded 3 contracts totaling \$300,000 for NEPA services
- Administered operations on 15 active timber sales
- Assisted in field preparations of approximately 700 acres on USFS timber sales and 630 BLM acres

Restoration Service Contracts

- Awarded 39 service contracts in excess of \$1 million
- Replaced 34 culverts and 2 bridges
- Graded 116 miles of road
- Awarded 8 contracts for fuels reduction to treat 2,936 acres
- Decommissioned 15 miles of road
- Delivered 4,208 truck loads of logs from GNA timber sales
