Subject: Kalispel Tribe Objects to Commercial Non-Navigational Encroachment Permit Application: L96S2798A (Joint application for permits USACOE, IDL, IDWR) - July 27, 2024

The Kalispel Tribe of Indians, as an adjacent landowner, is providing this letter to object to two elements (Riprap Requirements and Dredging Requirements) of the subject permit application. Our concerns continue to focus on potential impacts to known bull trout habitat, and we are offering the following comments (and potential solutions) to help ensure the proposed project is less impactful. As a reminder, the Idaho Department of Lands is legally obligated to protect public trust values, including fish and wildlife habitat, under Idaho Code §58-1301.

#### Inappropriateness of Shoreline Stabilization Approach

We question the heavy-handed shoreline stabilization approach being proposed, given the project's location within known bull trout habitat. The project is located on alluvial fan deposits, as described in detail within the hydrogeologic report for the project. These deposits are constantly being reworked by Trestle Creek flow and sediment, creating a rich mosaic of high-quality aquatic habitat. Riprap locks a landform in place, reducing deformability and limiting habitat-forming processes, including sediment recruitment. Because riprap is a permanent feature, it leads to a long-term reduction of habitat formation. We feel a more deformable shoreline stabilization approach that emphasizes the use of vegetation and natural toe stabilization materials would be more appropriate for this site, given the alluvial fan flow and sediment dynamics. The Pend Oreille Shoreline Bank Stabilization Guide (provided as an attachment) details a number of effective, vegetation and soil-based treatments that are appropriate for the Lake Pend Oreille region. The Tribe's Natural Resources Department (KNRD) would be willing to work with the project's design professionals to develop a more sensitive approach.

#### Inappropriateness of North Branch Trestle Creek Restoration Approach

A review of the 1896 General Land Office maps of the alluvial fan indicates multiple channels that likely changed alignment over time prior to landscape modification. We understand that past land use and associated channel straightening and simplification eliminated historic channels and restrict lateral movement of current channels across the alluvial fan but feel the proposed approach could be modified from a "stable channel" design to one that embraces an "active stream area" concept where lateral movement is recognized and enhanced. Doing so would likely enhance habitat-forming processes. Similar to the shoreline stabilization portion of the project, KNRD would be willing to work with the project's design professionals to develop a stream restoration approach more appropriate for the geomorphic context, especially since the restoration will take place on Tribal property.

We truly appreciate you taking the time to take our concerns into consideration.

It has come to our attention that Valiant Idaho has applied for an encroachment permit to install riprap, install a pedestrian bridge, and to dredge on Lake Pend Oreille on a property adjacent to the Kalispel Tribe's Trestle Creek conservation property. As an interest holder on the parcel, we recommend that the following items be considered.

- The parcel belonging to the Kalispel Tribe was permanently conserved in order to protect its unique conservation values which include scenic open space and relatively undisturbed wildlife habitat. Furthermore, the property is of cultural value to the Kalispel Tribe, whose rights of access for cultural and ceremonial purposes have been enshrined in the conservation easement document. It is important to recognize any adverse impacts to these conservation and cultural values that could result from the proposed actions.
- The state of Idaho requires that the public's health, interest, safety and welfare be taken into account when considering encroachments on the beds of waters of navigable lakes and that protection of property, navigation, fish and wildlife habitat, aquatic life, recreation, aesthetic beauty and water quality be given due consideration. These interests should be carefully weighed against any possible public benefits brought about as a result of the proposed action.

Our office has reviewed The Idaho Club's (Club) bridge permit and exemption request dated July 9, 2024. The Club's marina development plan includes a bridge crossing an un-named lagoon that is a tributary to Lake Pend O'reille at 48°17'00.0"N, 116°21'09.0"W. Lake Pend O'reille is a navigable waterway of the United States and is subject to Coast Guard jurisdiction for bridge permitting purposes.

The Commandant of the Coast Guard has given Advance Approval to the location and plans of bridges to be constructed across reaches of waterways navigable in law, but not actually navigated other than by logs, log rafts, rowboats, canoes, and small motorboats. Our office finds that the subject waterway meets the definition of 33 CFR § 115.70. The regulation is applicable to arms, embayments, or tributaries of water bodies or impoundments used for commerce.

Identification of an Advance Approval waterway is not a major federal action for purposes of the NEPA and other Federal environmental control laws. Such action is a Categorical Exclusion under NEPA. Therefore, **the Idaho Club Marina Pedestrian Bridge replacement will not require a Coast Guard bridge permit**. In such cases, the clearances provided for high water stages are considered adequate to meet the reasonable needs of navigation. Coast Guard Advanced Approval does not relieve the applicant of the responsibility to ensure compliance with any applicable federal, state, or local laws and regulations for the completed project. Although this project will not require a bridge permit, other areas of Coast Guard jurisdiction apply. The following conditions must be met:

- a. Bridge Completion form CG-4599.
- b. As built drawings that show the vertical and horizontal navigation clearances from ordinary high water.
- c. When the Idaho Club Marina Pedestrian Bridge is no longer used for transportation, it shall be removed in its entirety to the satisfaction of the Coast Guard District Commander.
- d. Submit a photo of the bridge for the USCG bridge file and database.

This "Advanced Approval" will not necessarily apply to future modifications of the subject bridge, or the construction of other bridges within this un-named lagoon. Contact this office before future modification to the subject bridge or the construction of other bridges across the lagoon adjacent to Lake Pend O'reille.
