Valiant Idaho, LLC and Valiant Idaho II, LLC have applied <https://www.idl.idaho.gov/lakes-rivers/administrative-hearings/idaho-club-trestle-creek-project/> requesting permission to **permit a commercial marina, to install riprap, to install a pedestrian bridge and to dredge on Lake Pend Oreille.**

Application L96S2798 was withdrawn by the applicants and a permit was therefore never issued by IDL.

Please submit your comments, recommendations, or objections to the Idaho Department of Lands via email to navigablewaterways@idl.idaho.gov by the **public hearing date which is yet to be determined (please check the website for date/location as the information becomes available)**, regarding the likely effect of the proposed encroachments upon navigation, adjacent property, lake and streambed value factors of navigation, fish and wildlife habitat, aquatic life, recreation, aesthetic beauty, or water quality. If you have concerns or are opposed to the project as proposed, please list your specific reasons for concern or opposition and any facts or documentation to support your position. You should recommend alternate plans if they are economically feasible to accomplish the purpose of the proposed encroachment. You should also recommend any mitigation measures or special restrictions/provisions you would like included as part of the permit if one is issued.

If you do not submit a comment, IDL will assume you have no objections to the application.
