All price quotes must be entered on the attached Schedule A. The signed Schedule A can be returned to either the Email or physical address listed below. Submitting vendors may provide pricing for printed shirts and sweatshirts, embroidered hats, or both. IDL reserves the right to award all items to one vendor or split the awards to two vendors in the following manner: one to the lowest responsive, responsible vendor for printed shirts and sweatshirts; and one to the lowest responsive, responsible vendor for embroidered hats. No more than two awards will be made. In the case of math errors, the UNIT PRICE will be correctly extended, and the corrected TOTAL will be evaluated.

If quoting printed shirts and sweatshirts only, please leave the line for embroidered hats blank on the Schedule A or simply enter “No Quote”. If supplying a quote for screen printed shirts and sweatshirts, a vendor **MUST** provide a price for each respective line to be considered for a purchase award.

If quoting on embroidered hats only, please leave all lines for printed shirts and sweatshirts blank on the Schedule A or simply enter “No Quote” on each respective line.

Upon award, vendor will (at no extra cost to IDL) ship one sample of a completed T-Shirt, 1 sample of a completed Hooded Sweatshirt AND 1 sample of a completed Embroidered Hat so that IDL can proof prior to issuing a notice-to-proceed for the full order. Proof delivery requested by March 28th, 2025. If IDL changes its size/quantity request prior to issuing a purchase order to the awarded vendor, it will contact the vendor for an updated shipping quote prior to issuing an order release.

- *Note: Specifications for garments have been stated in the Schedule A. **THESE ARE BRAND NAME and EXACT PRODUCT SPECIFICATIONS** to ensure consistency in inventory/deployment as well as controlling garment quality standards. IDL reserves the right to **rescind an entire award** if a sample deviates from the specifications listed – including a variation from the brands specified. IDL has verified any screenprinter has access to purchase raw stock from these companies.*
