On July 31, 2025, Objector Randy Folkins emailed the Hearing Officer and all parties, stating: "Please let it be known that I am hereby withdrawing my objection to case #PH-2025-NAV-22-002, OAH Case No. 25-320-04. Therefore, no hearing should be necessary as scheduled for August 5th, 2025."

After the Hearing Officer advised the parties that this email would be treated as a motion to dismiss the proceeding, Applicant Mark Allen emailed all parties on July 31, 2025 to advise: "I join Mr. Folkins' motion." Thereafter, on August 1, 2025, the Idaho Department of Lands (IDL) filed its Notice of Non-Opposition to Motion to Dismiss ("IDL Non-Opposition").

DISCUSSION

The pending Motion to Dismiss was made informally by Objector Folkins, with Applicant Allen joining the motion and IDL not opposing the motion. As reflected in the discussion on the record at the July 29, 2025 prehearing conference, as well as the summary provided by IDL in its Non-Opposition, the dismissal at this juncture appears to be reflected on at least some informal discussions between Applicant Allen and Objector Folkins implicating potential changes to the pending application which may require additional evaluative work by IDL with respect to any updated plans and/or a new permit application. Given that the requested dismissal appears predicated on actions which may or may not occur and lacks a definitive finality – and absent any

specific request otherwise - the Hearing Officer concludes a dismissal in this instance would be

one without prejudice.

Accordingly, based upon the submissions of the parties, it appears dismissal without

prejudice is appropriate. In ordering such dismissal, the Hearing Officer adopts IDL's clarification

that, given the current posture of this matter and resolution(s) being discussed by the Applicant

and Objector, this dismissal does not constitute a waiver of IDL's rights or policies, and does not

constitute a consent by IDL to encroachments being built to plans other than those submitted with

an application.

ORDER

Based upon the above, IT IS HEREBY ORDERED that this proceeding is DISMISSED

WITHOUT PREJUDICE.

IT IS SO ORDERED.
