As someone who has been directly involved in siting communication towers in the mountains of Idaho as my full time job, the lack of foresight and flexibility on the part of the cell company to choose a location and tower design which would be of least impact to an important and job-creating viewshed (while still serving the needs of first responders), is appalling. Sometimes the most ideal option for coverage isn't the right option from a historic, environmental, or recreational point of view, all of which are of utmost importance to all the citizens of Idaho, as it both provides them with a unique quality of life, and brings money into the state and supports the survival of small towns and local businesses. The precise location and design of this type of tower can certainly be adjusted to balance the needs of the users with the needs of the general public, especially when the height could potentially impact a resource and tourism attraction as unique as the dark skies and beautiful scenery of this area. Dear Members of the Board of Land Commissioners.

The Sawtooth Society previously sent a letter dated January 27th, 2020 with comments opposing the granting of the proposed lease # M700086 for a cell tower within the Sawtooth NRA.

The proposed 195-foot tall tower, three times taller than surrounding trees, would clearly violate a central value of the Sawtooth National Recreation Area, namely preserving the landscape and viewshed. The proposed tower, if approved, will significantly and unacceptably impact the viewshed, not just from the highway but from anywhere in the vicinity. We continue to oppose the granting of the lease. Please accept this letter on behalf of AT&T and FirstNet to provide background and additional information related to the proposed land lease for a FirstNet site near Redfish Lake as under consideration by the Idaho Department of Lands (IDL).

The Sawtooth National Recreation Area (SNRA) is a celebrated, and heavily touristed, area in Idaho. As a result, it is drawing more and more visitors to it every year. The area also includes an active, recently discovered earthquake fault line that shook loose dozens of avalanches throughout the region in early spring; it is in dense mixed forest that experiences seasonal wildfire; and it is home to one of the largest, and most heavily visited, glacial lakes in Idaho – Redfish Lake.

We are exploring the proposed new FirstNet site near Redfish Lake, intended to increase the safety of the area. FirstNet is the only nationwide, high-speed broadband communications platform purpose-built for America's first responders and the extended public safety community. Idaho's first responder community identified the area as a public safety priority in 2018 based upon the lack of existing coverage, the relative location to a large body of water, its proximity to a highway, use of the area as a staging ground for fighting wildfires, and the volume of visitors to the area. A FirstNet site near Redfish Lake would provide next-generation, interoperable communication between responding agencies during emergencies.

Bringing telecommunications infrastructure into mountainous, rugged areas is a balance. The height of the proposed FirstNet site is necessary to cover areas on and around the lake which remain a need by those responding to emergencies. We also know maintaining the aesthetic integrity of the area is important. That's why FirstNet and AT&T are working actively to ensure the visuals of the site optimally integrate with the surroundings while maintaining our focus on providing the best coverage to first responders. For example:

- 1) One Cell Site Versus Two: Through an extensive search, our network engineers and site acquisition teams identified an opportunity to locate a single cell site on IDL property that would enhance coverage typically required of two cell sites: (a) along Highway 75 and (b) on and around Redfish Lake. This single site location is adjacent to an existing provider's cell site. While this FirstNet site is 195 feet taller than the existing cell site it will extend coverage along Highway 75 to the north and south while also providing coverage at Redfish Lake, in particular the high traffic areas near Redfish Lake Lodge.
- 2) **Discrete Location:** Contrary to some reports, we are taking great care not to obscure views of the Sawtooths. In addition to being located in the same area as existing wireless infrastructure,

the majority of the FirstNet cell site will be hidden from view by a ridge when looking towards the cell site from Redfish Lake. For example, when standing at the popular north end of Redfish Lake facing the lake and the Sawtooth Range, this cell site would be over one mile *behind* the viewer to the northeast with the majority of the site hidden behind the ridge – in fact, the site will be hidden from view around the Redfish Lake Lodge.

- 3) **Camouflage Design:** Typically a cell site of this height would be a lattice-type structure. In this case, we opted for a monopole design with a slim profile. This is the preferred design given local needs and feedback we've received. Our construction team will also apply a neutral color tone to further disguise the site to blend with the surrounding area.
- 4) Dark-sky Friendly: Per FAA regulation pursuant to Title 14 of the Code of Federal Regulations, part 77.9, this planned cell site and location does not require external lighting per FAA regulation.
- 5) Exhausted Co-location Options: We have, in good faith, explored options to co-locate with the existing local telecommunications provider i.e., with a "drop-and-swap" that would allow for the height needed to cover the area and provide first responder coverage. That exploration ultimately did not lead to an alternative solution, so we resumed our application with IDL for the adjacent site.

We are committed to being good stewards while fulfilling our commitment to connect Idaho public safety. We believe our proposal meets those needs while serving the connectivity needs of the first responders who protect the lives of Idahoans and visitors to the area.

I am writing in response to the proposed lease # M700086 for a cell tower within the Sawtooth NRA. Please consider these recommendations prior to approving this application.

The mission of The Sawtooth Society is to protect, preserve and enhance the Sawtooth NRA. We are dedicated to preserving its open space and landscape vistas and to enhancing its recreation facilities and services.

This lease application by ATT and FirstNet to the State of Idaho (IDL) to construct and operate a commercial cell tower is located on a small parcel of State land located within the Sawtooth National Recreation Area (NRA). The proposed 195-foot tall, "galvanized grey" tower, three times taller than surrounding trees, would clearly violate a central purpose of the Sawtooth National Recreation Area, namely preserving the landscape and viewshed. This location, the grey color and the 195' height are all visually inappropriate options. The current tower at 100' and appropriately colored for its surroundings is already obvious and impacting the viewshed. A 195' tower painted in solid galvanized grey and inappropriately colored for its surroundings will significantly and unacceptably impact the viewshed, not just from the highway but from anywhere in the vicinity.

If the proposed lease # M700086 is approved, it will undermine decades of investment of public funds to protect the mountain vistas and landscapes of the Sawtooth NRA.

In 2013 when the current cell tower near the Fish Hatchery was proposed, the Sawtooth Society recognized there were benefits to having cellular coverage in the area including enhancing the safety of recreational users. At that time, the Society supported the first tower IF it addressed the following concerns. The Society felt these five attributes would minimize potential impacts to the vitally important visual and scenic resources of the Sawtooth NRA:

- 1. Minimize Tower Height
- 2. Avoid Towers Requiring Lights at the Top
- 3. Select Non-intrusive Paint Color
- 4. Construct Towers with Simplest Lattice Structure Possible
- 5. Place Tower Strategically to Minimize Visual Impacts.



The Society recommends ensuring these 5 attributes are priorities for any future structures on the state property. In addition, the Society recommends utilizing analysis of the RF propagation of a 100-foot tower vs a 200-foot tower on the site. Such research indicates a taller tower on the property does **not** provide materially better coverage. For all these reasons, a 100' tower height was the Society's recommendation in 2013 and is the Society's recommendation in 2020 and will be our recommendation in the future.

Today's application by ATT for a new tower on the State Land at the Fish Hatchery is impossible for us to support given the 195' height of the proposed tower, the likelihood of anticipated future required lighting and the lack of public input involved in the application process.

The Society therefore opposes the construction of the proposed new cell tower and requests IDL withhold approval of Lease No. M700086 until a visual impact simulation and RF propagation map is published publicly, alternate location are reviewed, an appropriate public comment period is opened, and public comments are accepted and reviewed.

The Society does support research into and future implementation of location-appropriate enhanced emergency response communications in the area. Research into enhanced communications should include the following actions by Idaho Department of Lands:

- Publicly publish a visual impact simulation and RF propagation map of proposed towers.
- Consider alternate solutions to ensure broader coverage such as co-locating on the current Custer

Telephone tower, multiple 100' towers or additional visually appropriate 100' towers at the southern end of the valley rather than installing a new 200' tower on the property.

• Ensure public input for lease <u># M700086</u> and any future cellular proposals.

Dear Members of the Idaho Board of Land Commissioners:

The Idaho Conservation League (ICL) hereby respectfully requests that the Land Board include consideration of IDL Communication Site Lease M700086, proposed to be issued to New Cingular Wireless, at its upcoming regular meeting on November 17, 2020. We also hereby request that the Land Board initiate a contested case with regards to this lease.

IDL Communications Site Lease M700086 would approve a communications site lease for a 195-foot tall cellular tower proposed by AT&T Mobility Corporation, Inc. as manager of New Cingular Wireless PCS, LLC.

ICL remains concerned that the location of the proposed tower will result in significant effects to resources of the surrounding Sawtooth National Recreation Area (SNRA). In particular, as we have previously commented, the proposed 195-foot tall tower, which is three times taller than surrounding trees, is in direct conflict with the core values protected by the enabling legislation of the SNRA. The SNRA was established by Congress to assure the preservation of the area's natural, scenic, historic, pastoral, and fish and wildlife values, and to provide for the enhancement of its recreational values. The proposed cell tower, which is proposed to be located adjacent to the

Sawtooth Scenic Byway between the highway and the scenic forests and mountain peaks, is clearly contrary to those values.

Furthermore, CusterTel's analysis indicates that "a taller tower on the property does not provide materially better coverage" due to the topography of the area (CusterTel comment letter to IDL). We also continue to have serious concerns that the proposed tower could include some form of lighting in the future. The project site is squarely in the middle of the Central Idaho Dark Sky Reserve (CIDSR), designated by the International Dark Sky Association in 2017. The CIDSR is the only such designation in the U.S., one of only 12 such reserves in the world, and was awarded "Gold Tier" status - the highest ranking for night sky quality. ICL was instrumental in establishing the CIDSR and we continue to work to protect and preserve the dark sky values of the area.

The Land Board previously heard comments on the proposed cellular tower lease from the lease applicant, ICL, the Mayor of Stanley, and other concerned residents and public stakeholders at its regular meeting on July 21, 2020. Although ICL and other commenters requested that the Land Board direct the Idaho Department of Lands (IDL) to pursue negotiations with the applicant and CusterTel over alternative arrangements that would minimize impacts of the proposed cellular tower, the Land Board concluded the July 21 meeting without taking any action or providing any direction to IDL staff.

Absent such Land Board direction, it appears that IDL staff have not sought to engage with CusterTel or the applicant about alternative possible arrangements, and instead are moving forward to finalize the lease as proposed by the applicant.

ICL is very concerned that an opportunity is being missed to develop an alternative approach that meets all interests and legal mandates, such as co-locating the AT&T cellular facility with the existing CusterTel site on state lands, and/or other site locations.

ICL seeks to ensure that the Land Board is fully informed about potential impacts of the proposed lease and alternatives, and to avoid possible litigation that may result if the proposed IDL lease is approved in its current form.

To that end, ICL requests that the Land Board address this issue at the November 17, 2020 regular meeting and direct IDL to conduct a contested case hearing over the requested lease.

As defined in the Idaho Administrative Procedure Act ("APA"), a "contested case" is defined as any "proceeding by an agency . . . that may result in the issuance of an order." *See* I.C. § 67-5240. *See also* IDAPA 20.01.01.002.4 (Land Board APA rules, defining a contested case as any "proceeding which results in the issuance of an order"); *Laughy v. Idaho Transportation Department*, 149 Idaho 867, 243 P.3d 1055 (Idaho 2010) (addressing agency duty to conduct contested case hearings over requested agency approvals).

Directly relevant here is Idaho Code 58-122, which provides that the Land Board may "in its discretion, determine[] that a contested case hearing would be of assistance to the board in the exercise of its duties and authorities." *See also* Idaho Code 54-104(4) (vesting Land Board with power to "review upon appeal all decisions of the director of the department of lands in contested matters"). In addition, Idaho Code 58-132 specifically acknowledges the importance of cooperating with the federal government in administering state lands, and directs that the Land Board "determine the best use or uses, viewed from the standpoint of general welfare, to be made of state land now owned or hereafter acquired. . . ." *See* I.C. 58-132.

Given the significant concerns already raised by ICL and many others regarding the proposed cellular tower, and its impacts on visual and other values that are cherished and protected within the SNRA, it is appropriate for the Land Board to direct IDL to conduct a contested case hearing pursuant to Idaho Code 58-122, the Idaho APA, and implementing Land Board regulations in this matter.

In conclusion, ICL respectfully asks that the Land Board (a) address the proposed lease at its November 2020 meeting, and (b) direct IDL to conduct a contested case hearing over the proposed lease before rendering any final decision.

The reasons for my opposition to the cell tower are as follows:

- Custer Telephone Cooperative already has an existing cell tower near the land in question, and has offered to let AT&T co-locate on its tower. This would allow for the increased cell coverage without adding another cell tower. This saves money and resources by not having to build a new, separate edifice (Betsy Russell The Spokesman Review 11/15/20).
- The new cell tower would be an offensive eyesore to the otherwise quite pristine Stanely Basin. I was raised in Challis, just 57 miles from Stanley, and have been coming to Stanley my whole life to backpack in the mountains, float on the Salmon River, and enjoy what makes the heart of Idaho so special: its unobstructed views of the Sawtooth Mountains. Building a cell tower on the land site proposed for the new tower would permanently alter this iconic view, and mar what is otherwise a special place cherished for its rustic beauty. Idahoans value mountains and rivers that set the state apart from an increasingly urbanized world, and this cell tower would be literally and figuratively a blemish on the landscape.
- Stanley is part of the Dark Sky Reserve, and the lights of this new cell tower would further compromise

These include preservation of natural, scenic, historic, pastoral, and fish and wildlife values, and to provide for the enhancement of the area's recreational values.

The proposed tower is also adjacent to the Sawtooth Scenic Byway, located between the highway and scenic forests and mountain peaks. I am also concerned that lighting associated with this tower may jeopardize this area's unique designation as an International Dark Sky Reserve, of which there are only 12 in the world.

To date, I have not had the opportunity to have my voice heard on this project. There has been no formal public comment period nor a concerted effort to involve the local community in the lease approval process. I urge the State of Idaho to make a more deliberate effort to keep me and others apprised of this project, solicit additional comments, and develop project alternatives to address the public's concern before moving forward with this proposal.

For these reasons, I implore you to withhold approval of this lease and find ways for the State of Idaho and the applicants to work together with the public and other agencies in the community to find a more appropriate solution. Any modified proposal should provide for a reasonable public comment period.
